### **Old Business**

GHA will cut two checks for inactive fees, one for Transurban and one for NEPP.

- GHA got some quotes for the fixing of the gate and the electrical work that needs to be completed. The board still has questions regarding whether the proposals include the key pad entry vs. radio key. We want GHA to get more estimates on the electrical and gate proposals. [GHA Follow Up]

- The light on 7901 Carrousel Ct has been repaired [Complete].
- Insurance has stated that there is no insurance specifically for playgrounds if we would rather increase liability coverage that would cover playground related issues. GHA is contacting the lawyers for a verdict on whether we have sufficient coverage. Then the next steps can be taken to check the area for the playground installation. [GHA Follow Up]
- We won't pursue Dominion Paving to repaint the numbers on Carrousel ct. We will need to make note that we need to repaint the numbers correctly the next time we do it.

- A mailing is going to go out to notify homeowners with a 4th decal to renew or their cars will begin to be towed. GHA will mail it out soon. [GHA Follow Up]
- The concrete steps will not be able to be repaired until the weather becomes warmer.
   The retaining wall would cost an additional amount along with the curb repairs. Alex
