Homeowner Issue/Concerns

- Brad Smith did a quote for a 4ft chain link fence near the back lot to gate trespassers
 and it came out to \$800-1500. The concern was that there was a report of a child
 abduction attempt in the neighborhood and the gate would prevent trespassers.
 However, this would make it difficult for people to walk around the neighborhood without
 a gate, and then the gate would need to be secured. We can discuss at a later time after
 we get some more community feedback.
- Brad Smith was curious about adding a dog park in the back lot next to the basketball court. This would be a fenced off area that would allow dogs to play together and hopefully prevent some poop around the neighborhood. A proposal was sent to the board for review and will be discussed at a later time.
- Brad Smith raised a question about towing policy for expired tags and wanted to know more details about contract details. He was told that the policy is because we did not want people to store cars on community spots.

Old Business

 The couches and loose wood have been removed, but it came out of the Raintree HOA budget. There are now paint cans sitting outside in the recycling bin and around it in Lower Wheatwheel. Gerry will collect pictures and give it to Ramin so he can create a post/letter.

New Business

- The board is looking for replanting trees this coming season and is looking for areas to target. The board is also looking to replace mulch with more green areas.
